In the matter of the appeal of

ASP Wireless Solutions, Inc.

FINAL ORDER 23-06

From a denial of certification as a Woman-owned Business Enterprise pursuant to Executive Law Article 15-A.

This order arises from an administrative appeal brought on behalf of ASP Wireless Solutions, Inc. ("ASP" or "Appellant") pursuant to section 144.2 of Title 5 of the New York Codes, Rules and Regulations. Appellant seeks reversal of the decision of the Division of Minority and Women's Business Development (the "Division"), dated February 4, 2020, to deny ASP's November 20, 2017, certification application as a Woman-owned Business Enterprise ("WBE").

Appellant initiated its appeal by sending a notice of appeal letter dated February 25, 2020, to the Division, requesting to appeal the denial determination via written submission. On May 8, 2020, the Division sent a notice to proceed by written appeal to the Appellant. Ms. Pamela Tralongo thereafter submitted a written appeal on behalf of ASP dated June 1, 2020. The Division responded to the written appeal submission with its Memorandum of Law dated April 21, 2023, and an Affidavit of Raymond Emanuel, Certification Director for the Division, with attached Exhibits. Administrative Law Judge ("ALJ") David A. Murad presided over the appeal.

The issues on appeal were whether Appellant sufficiently demonstrated that the woman owner relied upon for certification (1) has made capital contributions in the form of money, property, equipment or expertise in proportion to her equity interest, as required by 5 NYCRR § 144.2(a)(1); (2) makes decisions pertaining to the operation of the business enterprise, as required

by 5 NYCRR § 144.2(b)(1); and (3) has adequate managerial experience or technical competence to operate the business enterprise, as required by 5 NYCRR §144.2(b)(1)(i).

On May 17, 2023, the Division received a Recommended Order from ALJ Murad that recommended affirmation of the Division's denial of the application to certify ASP Wireless Solutions, Inc. as a WBE on the grounds set forth in the Division's February 4, 2020, denial letter.

After considering the appeal record, I accept the recommendation of the Administrative Law Judge as it pertains to the facts of this case. Incorporation by reference is hereby made with respect to the findings and conclusions of the Recommended Order.

It is hereby **ORDERED** that the decision to deny certification, dated February 4, 2020, is affirmed. Accordingly, ASP Wireless Solutions, Inc. will not be listed in the Division's directory for Minority and Women-owned Business Enterprises.
