University of Rochester NYFIRST – Life Science Initiative Fund (Capital and Working Capital Grant) – Rochester (Finger Lakes Region – Monroe County) - \$1,000,000 grant for the recruitment of Dr. Ruth Serra-Moreno from Texas Tech University, to serve as an Associate Professor of Microbiology and Immunology. Total project cost is \$3,000,000. Although the primary goal of this project is not job creation, 8 – 10 jobs are expected to be created over the next five years.

TOPTICA Capital – Regional Council Capital Fund (Capital Grant) – Pittsford (Finger Lakes Region – Monroe County) - \$400,000 grant for renovations to add a clean room and the purchase of new

machinery and equipment for laser development at 1120 Pittsford Victor Road. Total project cost is \$2,674,000. 22 net new jobs will be created for this project.

Town of Victor Adams Street Extension Study – Regional Council Capital Fund (Capital Grant) – Victor (Finger Lakes Region – Ontario County) - \$32,722 grant for a portion of expenses to complete the Adams Street Extension Feasibility Study. Total project cost is \$70,444. There are no direct jobs associated with the project.
