**Plan 1 – 5 Chestnut Geneseo Street Development Capital – New York Forward Round 1 (Capital Grant)– Geneseo (Finger Lakes Region – Livingston County)** – ESD proposes to make a \$500,000 grant for the renovation, design and engineering of 5 Chestnut Street in the Village of Geneseo into 2-floor mixed-use development with the first floor being converted into commercial space and the second floor being converted into 3 market rate, 2 bedroom apartments. Total project cost is \$1,040,375. There are no direct jobs associated with the project.

**Plan 2 - DePaul Community Services Capital – Regional Council Capital Fund RC14 – NFP (Capital Grant) – Rochester (Finger Lakes Region – Monroe County)** – ESD proposes to make a \$49,484.54 grant for the renovation of WorkGuide’s existing offices to accommodate 3 new employees and serve

up to 75 additional individuals in its supported employment program. Total project cost is \$98,969.07.
